Release and Waiver of Liability, Assumption of Risk and Indemnity Agreement

In Consideration of being permitted to compete, officiate, observe, work for, participate in any way in the event of being permitted to enter for any purpose any restricted area (defined as an area requiring special authorization, credentials, or permission to enter or any area to which admission by the general public is restricted or prohibited). The undersigned for himself or herself, his or her personal representatives, heirs and next of kin:

1. Acknowledges, agrees, and represents that he or she has or will immediately upon entering any such restricted areas, and will continuously thereafter, inspect the restricted areas which he/she enters and he/she further agrees and warrants that, if at any time, he/she feels anything to be unsafe, he/she will leave the restricted area and/or refuse to participate in the event.

2. Hereby releases, waives, discharges and covenants not to sue KRC Racing Schools, Incorporated, track owner, participants, KRC Racing Schools, Incorporated, racing associations, sanctioning organizations, state of California, their agents, officers, servants and employees, sponsors, advertisers, owners, lessors or premises used to conduct the event, premises and event inspectors, surveyors, underwriters, consultants, and others who give recommendations, directions, or instructions, or engage in risk evaluation of loss control activities regarding the premises or event and each of them, their directors, officers, agents, and employees, all for the purpose herein referred to as "Releasees", from all liability to the undersigned, his/her personal

representatives, assigns, heirs, and next of kin, for any and all loss or damage, and any claim or demands therefore on account of injury to the person or property or resulting in death of the undersigned arising out of or related to the event, whether caused by the negligence of the releasees or otherwise.

3. Hereby agrees to indemnify and save and hold harmless the releasees and each of them from any loss, liability, damage or cost they may incur arising out of or related to the event, whether caused by the negligence of the releasee or otherwise.

4. Hereby assumes full responsibility for any risk of bodily injury, death or property damage arising out of or related to the event whether caused by the negligence of releasees or otherwise.

5. Hereby acknowledges the activities of the event are very dangerous and involve the risk of serious injury and/or death, and/or property damage. Each of the undersigned also expressly acknowledges that injuries received may be compounded or increased by negligent rescue operations or procedures of the releasees.

6. Hereby agrees that the release and waiver of liability, assumption of risk and indemnity agreement extends to all acts of negligence by the releasees, including negligent rescue operations and is intended to be as broad and inclusive as is permitted by laws of the province or state in which the event(s) is/are conducted and that if any portion thereof is held invalid. It is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

I have read this release and waiver of liability, assumption of risk, and indemnity agreement, fully understand its terms, understand that I have given up substantial rights by signing it, and have signed it freely and voluntarily without any inducement, assurance, or guarantee being made to me and intend my signature to be complete and unconditional release of all liability to the great extent allowed by law.
